Old Business:

Roofing Replacement 2020: The BOD had 'Best and Final' quotes from RLK Roof Designs, Inc. and Reliant Roofing. There was a lengthy discussion about the merits of each bid. A motion was made by Lewis Balentine to award the contract to Reliant Roofing. The motion was seconded by Angela Stamps and passed unanimously.

There are two issues to be settled with the vendor:

- 1) Shingle color. The BOD has tentatively selected "Cobblestone Gray".
- 2) The BOD would like the replacement 1x2 boards under the drip edge "finish painted" rather than "primed and ready for for paint". A single neutral color is acceptable.

The secretary was directed to notify each vendor of the award via email and to arrange a meeting with Joe Heiliger of Reliant Roofing to address the issues and arrange a schedule for the work to be accomplished. (*Date of meeting was set for 13 February 2020*)

New Business:

Solid Waste Collection:

There was a short discussion about the tendency of the City of Houston waste collection service to accidentally dump waste on the street when manipulating the collection bins. It was suggested that the individual write a letter to Director of Houston's Solid Waste Management Department, Harry J. Hayes and copy the local city council representative, Amy Peck.

New Construction in the Local Area:

There was a short discussion about the new subdivision construction in the area specifically regarding the current traffic problems and possible future drainage issues. The drastic five foot elevation transition around the property blatantly emphasizes the potential for future drainage problems. It was concluded that there was little the BOD could do to address the issues other than making the local City Council Member aware of of our concerns.
