General Housekeeping

Greetings from Kempwood Villa Townhouse Association!

Monthly Maintenance Fee Increase: At the 2022 annual meeting KVTA (Kempwood Villa Townhouse Association) board members voted to set the HOA Maintenance Fee to \$1,116 per year or \$93.00 per month effective 1 January 2023. The fee is due on the first day of the month. A late fee may be accessed after the tenth day of the month. Late fees are \$15 for the current month plus 10% of the outstanding balance over 30 days old. See the attached statement for your unit's account. If you know of or find any discrepancy, please inform me as soon as possible at treasurer@kempwoodvillata.org.

**Projects:** Soffits were checked, and repairs were made to any holes that were found. We are going to begin getting bids to have the paint redone on any units with wood on the exterior.

**Fire Safety:** One of our units had a small house fire this year after the bathroom fan was left on after the motor had gone out. We wanted to let everyone know about the risk of fire with the older motors so that it doesn't happen to anyone else. It is recommended to check your fire alarms to make sure they are in good working order. **Home Insurance:** All units are required to have full home insurance, not condo insurance. KVTA HOA needs a copy of every unit's insurance policy to keep on file.

**Trash/Recycling Pickup:** Please remember to put your trash/recycling cans out Thursday afternoons and take them back to your units by Saturday morning. Tree and heavy trash pick up happens

**Parking:** Visitors are to use visitor parking spots. Owners and renters should park in their personal covered parking. No one should park along the fence.
